DRIVING DIRECTIONS

FROM AIRPORT

- Merge onto International Gateway
- Use the left 2 lanes to stay on International Gateway
- Follow signs for I-670 W/U.S. 62 W/Columbus
- Merge onto I-670 W/US-62 W
- Keep left to stay on I-670 W
- Merge onto I-70 W
- Take exit 93 to merge onto I-270 N toward Cleveland
- Take exit 15 for Tuttle Crossing Boulevard
- Turn left onto Tuttle Crossing Boulevard
- Turn right at the 2nd traffic light onto Emerald Parkway
- At the traffic circle, take the 2nd exit and stay on Emerald Parkway
- At the traffic circle, take the 1st exit onto Glendon Court

FROM SOUTH

- Take I-71 N to Columbus
- Take exit 101 to merge onto I-270 W toward Dayton
- Take exit 15 for Tuttle Crossing Boulevard
- Turn left onto Tuttle Crossing Boulevard
- Turn right at the 2nd traffic light onto Emerald Parkway
- At the traffic circle, take the 2nd exit and stay on Emerald Parkway
- At the traffic circle, take the 1st exit onto Glendon Court

FROM NORTH

- Take I-71 S to Columbus
- Take exit 119 B toward Dayton
- Merge onto I-270 W
- Take exit 15 for Tuttle Crossing Boulevard
- Turn right onto Tuttle Crossing Boulevard
- Turn right at the 1st traffic light onto Emerald Parkway
- At the traffic circle, take the 2nd exit and stay on Emerald Parkway
- At the traffic circle, take the 1st exit onto Glendon Court

FROM WEST

- Take I-70 E to Columbus
- Take the exit toward I-270 N
- Follow signs for I-270 N/Cleveland
- Merge onto I-270 N
- Take exit 15 for Tuttle Crossing Boulevard
- Turn left onto Tuttle Crossing Boulevard
- Turn right at the 2nd traffic light onto Emerald Parkway
- At the traffic circle, take the 2nd exit and stay on Emerald Parkway
- At the traffic circle, take the 1st exit onto Glendon Court

FROM EAST

- Take I-70 W to Columbus
- Merge onto I-71 S
- Keep right to continue on I-70 W
- Take exit 93 to merge onto I-270 N toward Cleveland
- Take exit 15 for Tuttle Crossing Boulevard
- Turn left onto Tuttle Crossing Boulevard
- Turn right at the 2nd traffic light onto Emerald Parkway
- At the traffic circle, take the 2nd exit and stay on Emerald Parkway
- At the traffic circle, take the 1st exit onto Glendon Court
